

SUMMERLIN PARKWAY TRAIL PROJECT CC-215 to Rampart Boulevard

UPDATE: Upcoming Full Closure of Crestdale Lane

The City of Las Vegas is making swift progress on the new 3.5-mile shared-use trail between the Summerlin Interchange and Rampart Boulevard adjacent to Summerlin Parkway. In the past few weeks, crews have removed shrubs and installed foundations for lighting along the trail.

In late January 2026, the City of Las Vegas will close Crestdale Lane between Covington Cross and Trailwood drives for three months to enable the construction of a trail tunnel underneath Crestdale Lane.

During this time, crews will excavate below Crestdale Lane on the south side of Summerlin Parkway to build a new tunnel, install electrical for lighting, grade the trail path, and pave the final alignment.

This trail will ultimately connect the existing CC-215 Beltway Trail with the Bonanza Trail and tie it into a pedestrian bridge spanning CC-215, which is currently under construction as part of Clark County's Summerlin Interchange project.

The segment now under construction stretches from Summerlin Parkway to Anasazi Drive, running alongside the north side of Summerlin Parkway, then switching to the south side of Summerlin Parkway between Anasazi Drive and Rampart Boulevard.

12-foot-wide asphalt pathway

5% Regional Transportation Commission (RTC) of Southern Nevada

Construction work hours: 7am-6pm

Project duration: 18 months

TRAFFIC IMPACTS

The City of Las Vegas is working closely with Clark County's Summerlin Interchange team to minimize traffic impacts throughout construction.

- Minimal impacts to Summerlin Parkway are expected
- Lane Restrictions are anticipated as trail crossings at Anasazi Drive,
 Town Center Drive and Rampart Boulevard are constructed
- During construction of a tunnel at Crestdale lane, a full roadway closure will be necessary for public safety. This closure is currently scheduled to begin in January 2026 and be in place for three months.
