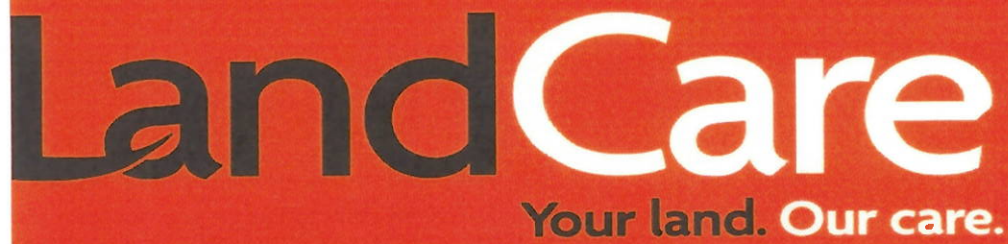

5. Fire-Fighting Measures

Advice on system design:
